Personal Device Usage Guidelines

Technology and technology empowered students are here to stay. Bullitt County Public Schools wants to capitalize on young people's affinity for technology and engage those students in learning in a more relevant way within a world that is becoming increasingly technology driven. The focus in allowing the use of personal devices by students is an effort to help them work independently both in and out of school. Research indicates that students who have access to technology on a regular basis show a significant improvement in their learning skills over students who do not have regular access. With this in mind, every effort will be made to provide access to quality resources that will hopefully reshape how students learn.

By allowing you to use your personal computing device at school, there becomes a need to establish rules, policies, and regulations that will govern the use of the equipment. Establishing this new environment for such learning takes careful planning and consideration. We hope the useful information below provides you with advice and best practices for using personal devices in the classroom. This information is not meant to be "all inclusive" and will remain a work in progress as the use of personal devices evolves. While the success of any program of this magnitude depends on individual goals, school-wide goals, environments, planning, organization, and personnel - certain strategies can be universal. The keys to our goal and objective setting process will focus around the enhancement of student learning.

Personal Electronic Devices / BYOD examples: laptop computers, netbook computers, tablets (iPad, Kindle), eReaders (Nook, Kindle, iPad), MP3 players (iPod), cell phones if permitted.

NOTE: Principals and Teachers may set additional requirements for personal device use in their classroom.

Use of Personal Devices at School

The student is only allowed to use their personal device with the permission of the Principal and/or the teacher. When students are <u>not</u> utilizing personal devices for educational purposes, they should be stored in a secured place (i.e. lockers with the lock securely fastened, teacher designated area). *Students should take their personal devices home every day after school, regardless of whether or not they are needed.* HS/MS: Personal devices should never be stored in a vehicle at school or at home.

Loss, Theft, or Damage while on School Property

Students assume all risk of theft or damage while on school property. Students should exercise responsible behavior in the use and protection (protective cases) of any personal devices while on school property. Bullitt County Public Schools will not be responsible for personal property, including computers and mobile devices.

Personal Devices Left in Unsupervised Areas

Under no circumstances should personal devices be left in unsupervised areas. Any personal device left in an unsupervised area is in danger of being stolen.

Acceptable Use Policy

Use of personal devices while on school or district property is subject to the provisions in the District Acceptable Use Policy (can be found at <u>http://ww2.bullittschools.org/technology/</u>) and the Telecommunications Device Policy (reference policy number 09.4261).

Internet Filtering

Use of devices or software to bypass district internet filtering is a violation of the District Acceptable Use **Policy** and disciplinary action shall be taken.

Wireless Network SSID

Students may only connect to **<u>BCPSMobile</u>** or other approved wireless network while on school or district property.

<u>Email</u>

By state law, only BCPS email shall be accessible using the BCPS network facilities.

Laptops - Virus and Malware

Software to remove viruses or malware shall be installed on personal devices before connecting to any BCPS network. Free anti-virus software can be found at AVG.COM, or may be purchased from other reputable vendors such as Microsoft, Norton's, McAfee and others.

Sound

Sound must be muted at all times in the classroom unless permission is obtained from the teacher for instructional purposes. Personal headphones or ear buds must be used for activities that have sound associated with them, which shall be provided by the student.

Screen Saver/Desktop Wallpaper or Background

Inappropriate media may not be displayed on screen savers, desktop wallpaper or backgrounds while in use at school. Presence of guns, weapons, pornographic materials, inappropriate language, alcohol, drug, and gang related symbols, pictures or applications will result in disciplinary actions.

Technical Assistance

Bullitt County Public Schools Technology Department cannot repair or troubleshoot problems with personal devices. We will provide wireless connectivity with instructions on how to connect and access eLockers, Bullitt Cloud, or other storage devices for personal storage.
